ASSUMPTION OF RISK AND RELEASE FORM**

In consideration for being permitted to utilize the facilities and equipment of the University of Central Missouri, to engage in aircraft and/or glider activities, including, but not limited to, ingress, egress of the aircraft and/or glider, take off, flight, landing, related operations of aircraft and/or glider flight, the ground instruction and ground handling related activities (hereinafter collectively referred to as "Aircraft and/or glider Activities"),

I hereby **RELEASE AND DISCHARGE** (____) *initials*, the University of Central Missouri, their officers, directors, agents, employees, instructors, riggers, pilots, ground handlers, and the owners of the aircraft and/or glider, equipment manufacturers, landowners and airport or other take-off or landing site utilized for aircraft and/or glider flight or activities (hereinafter collectively referred to as "Released Parties") from any and all liability, claims and demands or causes of action that I may hereafter have for injuries and damages arising out of my participation in the Aircraft and/or glider Activities, including, but not limited to losses **CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.** (____) *initials*

2. I further agree that **I WILL NOT SUE OR MAKE A CLAIM** against the Released Parties for damages or other losses sustained as result of my participation in Aircraft and/or glider Activities. (____) *initials* I also agree to **INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS** from all claims, judgments and costs, including attorney's fees incurred in connection with any action brought as a result of my participation in my Aircraft and/or glider Activities. (____) *initials*

3. I understand and acknowledge that Aircraft and/or glider Activities have inherent dangers that no amount of care, caution, instruction or expertise can eliminate and I do hereby acknowledge that I am fully aware of all risks and hazards that may be directly or inherently involved in this Activity, which include but are not limited to, (1) minor injuries such as scratches, bruises, and sprains; (2) major injuries such as eye injury or loss of sight, joint or back injuries, fractured or broken bones, heart attacks and concussions; and (3) catastrophic injuries including paralysis and death. **I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK WHILE PARTICIPATING IN AIRCRAFT AND/OR GLIDER ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.** (____) *initials*

I hereby expressly recognize that this Assumption of Risk and Release of liability is a contract pursuant to which I have released any and all claims against the Released Parties resulting from my **AIRCRAFT AND/OR GLIDER ACTIVITIES** including any claims caused by the negligence of the Released Parties

I HAVE CAREFULLY READ THIS AGREEMENT AND RELEASE OF LIABILITY, AND I FULLY UNDERSTAND ITS CONTENTS AND SIGN IT OF MY OWN FREE WILL.
